INVESTMENT OBJECTIVE

The Fund seeks to provide a high level of current income that is not subject to federal income tax.

INVESTMENT STRATEGY

The Fund typically invests in medium- and lower-quality bonds, which are bonds that are rated BBB+ or lower by Standard & Poor's Ratings Services ("Standard & Poor's"), are comparably rated by another nationally recognized statistical rating organization ("NRSRO") or, if unrated, are determined by the Fund's adviser to be of comparable quality. The Fund's typical investments include non-investment grade debt securities (commonly called junk bonds), which are rated BB+ or lower by Standard & Poor's, comparably rated by another NRSRO or, if unrated, determined by the adviser to be of comparable quality. The Fund may invest an unlimited amount of its total assets in noninvestment grade debt securities. Although the Fund's adviser considers credit ratings in selecting investments for the Fund, the adviser bases its investment decision for a particular instrument primarily on its own credit analysis and not on an NRSRO's credit rating.




TOP TEN SECTORS (Percentages are based on total investments)
